### Section 19. Authorship Speeches

Speeches introducing legislation are allotted up to three minutes, followed by two minutes of questioning by other competitors. Any contestant from the school who wrote the legislation gets the privilege of recognition (called authorship), regardless of precedence.

- A. Should no student from the authoring school be present in the chamber to claim authorship, the presiding officer may recognize a sponsor from the chamber to give a sponsorship speech, following the regular priority system.
- B. In the event that more than one student from the same school is present in the chamber, priority will be given to the student from that school with the least speeches. If tied, priority will go to student from that school who has spoken least recently.
- C. Any contestant giving the authorship or sponsorship speech must relinquish their next priority card, following numerical order.
- D. Whether an authorship or a sponsorship speech, the introduction speech shall be followed by a two-minute questioning period. During the two-minute cross-examination in all rounds, questioners are limited to one question per recognition.

**Rationale:**

Authorship provides an incentive for schools to submit legislation that they have recently written and is of a higher quality than we sometimes receive. Following NSDA practice, if the school is not represented in the chamber, the privilege is extended to their closest neighbors.

Speakers for and against a bill/resolution are limited to three minutes plus one minute of cross-examination. Questioners shall be recognized at the discretion of the presiding officer.

- A. **In preliminary rounds**, questioners are limited to one question per recognition.
- B. **In semi-final and final rounds, direct questioning shall be used. The presiding officer will recognize two questioners for a cross-examination period of no more than 30 seconds each.**
- C. **Direct questioning shall not be used for authorship or sponsorship speeches.**

Speakers shall not be interrupted during the three-minute speaking period.

### Rationale:

By adding direct questioning to the semi-final and final rounds of Congress, we are continuing to align our practices with the NSDA. Direct questioning allows for a more thorough cross-examination of the speaker, enhancing the debate aspects of Congress. It also helps to better prepare the competitors for real world applications of the event.

2. Time: Each contestant shall be given time signals for at least the final two minutes, one minute, and half a minute of the contestant's speech. If these minimal time signals are not provided, then the contestant may not be penalized for going over the time limit. If these minimal time signals have been provided and the contestant exceeds the time limit by more than 15 seconds, the speaker will be penalized by a lowering of one rank by tab room officials. **For each final round, a tournament official or designee shall serve as the official timer and will provide the time signals to the contestants. This may be extended to the semi-final round at the discretion of the Tournament Director or designee.**

**Rationale:**

Time signals are very important for spontaneous events. Sometimes judges say they will provide the signals and then forget. Currently, an official timer is being used in every final event. We feel it is important to have it in the rules that an official timer will be used in the final round.

Transcripts may only be printed from websites on the National Speech and Debate Association Approved Website List. Online transcripts must meet all other event requirements.~~

Selections available only on nationally distributed phonograph, compact disc, audio or video tape recordings, shall be permitted only if the material used is printed on the jacket or box of the recording or on a printed insert with the recording. Only the original printed source or a photocopy of the original printed source shall be considered adequate proof of publication.

POI often deals with topics that have limited published literary works and typically use articles. Students should be allowed to use current articles to keep their piece relevant. Students will gain educational experience from adapting their piece as newer articles become available.

Unpublished material used for introductions and transitions of interpretations must be the original work of the contestant. Published and/or quoted material used for introductions and transitions of interpretations must be properly cited according to MLA guidelines. Transitions and other added material must not change the author's intent.

d. League Presidents shall forward to the Area Chairperson proper photocopies of all contestant interpretations that have qualified for the State Tournament. The coach, contestant, parent/guardian, and a school administrator must sign the CHSSA coversheet and attach it to all scripts submitted for qualification for the State Tournament.

All official ballots shall list the nominees in alphabetical order and provide a space to vote for "none of the above" and a space to indicate "abstention" which shall not be included in the total count of votes.
5. The Historian will ~~be~~ report to the CHSSA president who shall notify candidates of result by March 1.
6. Elections to the Hall of Fame shall require a 60% vote for a nominee. Should a nominee fail to achieve a 60% vote, but receives a minimum of a 40% vote, that nominee shall be retained on the ballot for the following year.

**Editing an author's work down to 10 minutes is a creative exercise. However, it shall be a violation to create new piecemeal sentences from the individual words or phrases of the author unless such words or phrases follow the rules for 'added words' and will be counted toward the limit of 'added words'.**

**Rationale: The creative process of editing an author's work has gotten out of hand. Much beyond editing to cut the work down to 10 minutes, to shorten the time line, to bridge two distant periods of time, or to update, competitors are now taking single words found over 50 pages and combining them to make a joke or comment never referenced by the author. OPP is now freely being employed by the trick of using single words and phrases of the author and creating brand new sentences that were never apart of the original work. This abuse demeans the author's work and the essence of interpretive events.**

~~6. In the semifinal round, the highest remaining seed will debate the lowest remaining seed. The other two seeds debate in the other semifinal round. If this results in a pairing wherein a contestant is scheduled to debate an opponent from the same school, the lower seeds should swap opponents. If this adjustment yields a new, similar conflict, then the original pairings will be used for the semifinals.~~

**Rationale:**

When we adopted the new debate rules with four prelims and an elim bracket for the top sixteen, we added rule XII.3.G.4 (see above). This should have superseded rule XII.3.G.6, since their wording conflicts, but either the deletion was not made or coaches argued for keeping the older rule. This leads to a strange situation, in which we start a bracket, follow it for two rounds, and then break it for the semi-finals. Allow me to illustrate why this is a problem (cont.) . . .

At this year's state tournament, Policy Debate shows us how a bracket should work (see attached photo of bracket). The branches have been seeded based on prelim ranks, and the winner of each debate proceeds down the branch until the last two teams meet in the finals.

LD shows us what happens when a bracket is broken and debaters don't follow the branch they are seeded onto (see attached photo). 15<sup>th</sup> ranked Faraaz Godil beat the #2 seed Christine Tu. He then continued to face and defeat the #7 seed (Gottlieb). By following the bracket he should then debate #3 (Hitchings), but instead he is jumped up to a higher branch to face the 1<sup>st</sup> ranked debater (Pillai) who has been undefeated the entire tournament. At the same time, 4<sup>th</sup> seed Durgude is saved from having to face Pillai, and allowed to debate the lower ranked Hitchings.

Is this shift significant? Its effects are probably minor, and might not have changed the outcome of the tournament. After all, Godil beat Pillai and faced Hitchings in the final round.

Is this shift fair? No. Brackets are created to give the top-ranked debaters easier competition on the road to the finals. When a "Cinderella" team defeats a higher ranked team, they should inherit that easier path. They've earned that reward, but our status quo denies it to them.

Time: **Judges are not required to give time signals but are the official timekeepers.** Each contestant shall be **allowed to use a time keeping device, if it is a cell phone it must be on airplane mode and only on the stopwatch function. The contestant may use the device only to keep time during their speech; it may NOT be used as a prop.** ~~given time signals for at least the final two minutes, one minute, and half a minute of the contestant's speech. If these minimal time signals are not provided, then the contestant may not be penalized for going over the time limit. If these minimal time signals have been provided and~~ **If the contestant exceeds the time limit by more than 15 seconds, the speaker will be penalized by a lowering of one rank by tab room officials.**

**Rationale:**

It is often difficult for the judges to provide time signals while judging. Sometimes the judges forget, and the timing sometimes is inaccurate which makes it difficult for the contestant. This puts the ownership of timing and pacing on the contestant and not the judge. This is becoming the norm on the circuit as well.
